# **Challenge & Change**

- Medicaid customers have had continuous coverage since March 2020; no renewal has been needed.
- Address updates may not have happened since 2019.
- Renewal notices will start going out at the beginning of May 2023 (for people whose renewals are due in June).
- People will renew throughout the year, depending on due date



## Why It Matters

- HFS will mail renewal notices to addresses on file; coverage could lapse if customers miss it.
- Address must be updated by the date the notice is sent.
- Notices to be spread over 12 months e.g., a client who renewed or joined in July of a previous year will get a notice saying to renew in July.



# Urgent Need

Help Medicaid customers update their addresses and get ready to renew their coverage.

# **Toolkit Main Messages**

Medicaid members! Don't risk losing your health insurance. Update your address with Illinois Medicaid.

Illinois Medicaid needs to send you paperwork. To keep your health insurance, use an address where mail can always reach you.

Updating your address is easy, fast and free. Call 877-805-5312 from 7:45am–4:30pm or visit medicaid.illinois.gov. If you use a TTY, call 1-877-204-1012.



How Groups Can Use Messages

- Help customers 1:1 (gold standard)
  - Sit with customer and enter info online.
    Customer must be present.
  - Tell customers how to do it on their phone while they wait (or provide computer)
  - By phone, tell customers how to do it online or connect them to 877-805-5312
- Hand out flyers 1:1, verbalizing importance
- Email, text, call, mail customers
- Add message to "My Chart" (for providers)
- Post flyers and leave stack
- Ask other organizations to share messages from toolkit



# **Example: Provider Office**

- Walk customer through process:
- Ask if customer has moved in last 4 years
- Check MEDI (if you have access) to see if address on file is up-to-date
- Update address online while they sit with you or give them handout to use in your office
- May also include message in MyChart.





### **Example: Social Services (e.g. Food Pantry)**

- Put flyer in bag of food, e.g., telling customers to look for it
- Convey that their benefits depend on updated address
- Post in common areas

### **Renewal Mail Timeline**

First renewals sent (to arrive early May for those due June 1)	04/27/2023
First renewals due	06/01/2023
First possible loss of coverage for people who no longer qualify	07/01/2023
Renewals sent for people due by July	05/30/2023
Renewals due by July	07/01/2023
Possible loss of coverage for people due by July	08/01/2023
Renewals sent for people due by August	06/29/2023
Renewals due by August	08/01/2023
Possible loss of coverage for people due by August	09/01/2023
and this pattern continues for each month of the year.
